State's Average Weekly Wage (SAWW):

From 1/15/10 to 7/15/10: \$ 922.45
From 7/15/10 to 1/15/11: \$ 925.08

Maximum Temporary Total Rate (TT):

From 1/15/10 to 7/15/10: \$1,243.00**
From 7/15/10 to 1/15/11: \$1,243.00**

Maximum Permanent Partial Disability

Rate (PPD): From 7/1/09 to 7/1/10: \$ 664.72**
From 7/1/10 to 7/1/11: (TBD 1/1/11)

Minimum Rate for Death and Permanent Total

(PTD) cases: From 1/15/10 to 7/15/10: \$ 466.13**
From 7/15/10 to 1/15/11: \$ 466.13**

Rate Calculations - Short Method:

$AWW \div 3 \times 2 = TT \text{ Rate} \times .9 = PPD \text{ Rate}$

Travel Expense Allowed by Commission:

50.0¢ per mile (effective 1/1/10 to present)

* Maximum PPD rates are in effect from 7/1 of each year to 7/1 of the following year.

**The Commission takes the position Section 8(b)4 of the Act only allows a proportionate weekly rate increase when the SAWW increases with no corresponding provision allowing a decrease when the SAWW decreases. We believe this position is inaccurate since this statute also says the maximum TT rate shall be 133% of the SAWW. In our opinion the maximum TT rate for injuries occurring between 1/15/10 and 7/15/10 should be \$1,229.93, the maximum PPD rate for injuries occurring 7/1/09 to 7/1/10 should be \$657.74, and the minimum rate for the recoveries specified in section 8(b)4.1 for injuries occurring 1/15/10 to 7/15/10 should be \$461.23 (50% of the \$922.45 SAWW). For injuries occurring 7/15/10 to 1/15/11 the maximum TT rate should be \$1,233.44 and the current minimum should be \$462.54.

Note: The minimum rate for TTD and PPD is increased to 66-2/3% of the sum of the Federal minimum wage or the Illinois minimum wage, whichever is higher, multiplied by 40 hours. The percentage rate shall be increased by 10% for each spouse and child, not to exceed 100% of the total minimum wage calculation. As of 2/1/06, the Illinois minimum wage of \$6.50 per hour will apply; the minimum hourly rate increased to \$7.50 on 7/1/07, to \$7.75 on 7/1/08, and to \$8.00 on 7/1/09. The Commission reports no increase for injuries on and after 7/1/10.
